# External trade of goods in 2006

Summary

In 2006, goods were exported from Iceland for 242,700 million ISK fob and imported into Iceland for 401,200 million ISK fob, 432,100 million ISK cif. The import figures are higher than previously published figures for the year 2006 due to information of imports received after publication of the 2006 figures. Thus there was a trade deficit of 158,500 million ISK compared with 94,500 million ISK deficit in 2005. Exports values increased by 24.9% at current prices while imports increased by 37.7%. Marine products constituted 51.2% of all exports, increasing in value by 12.9% from the year before, at current prices. Manufacturing products were 38.3% of the total exports, increasing in value by 39.3%. The largest import categories were industrial supplies accounting for 25.1% of total imports, capital goods (except for transport) with 23.8% of total imports and transport equipments with 22.4% share. Measured in ISK, the increase in imports was greatest in transport equipments. The share of EEA countries was 74.8% in exports and 64.7% in imports. The Netherlands was the largest trading partner in 2006, accounting for 16.6% of total, while the largest share of imports came from the United States, or 12.9%.

#### **Balance of trade**

Exports 242,700 million fob and imports 432,100 million cif Table 1 shows the development of external trade during the past decade. Imports are presented at cif-prices and exports at fob-prices. In 2006 total exports amounted to 242,700 million ISK fob as compared with total imports of 432,100 million ISK cif. This means that the fob/cif balance of trade in 2006 was unfavourable by 189,400 million ISK. Measured this way, there has been a deficit in external trade during the whole decade. The deficit has varied in size, from approximately 1.6% of the export value in 2002 to 78.0% in 2006. The trade deficit in 2005 equalled 61.5% of the export value, 28.7% in 2004 and 18.6% in 2003.

Balance of trade deficit






Figure 2. External trade 1985–2006

For national accounts purposes, the balance of trade is calculated from the fob value of both imports and exports. Imports fob in 2006 amounted to 401,200 million ISK, which means that there was a trade deficit of 158.500 million ISK. Table 2 shows that the balance of trade fob has been favourable for one year of the ten years reported here, in 2002, 1.6% of GDP. On the other hand, there was a trade deficit in 9 of last 10 years, the largest amounting to 13.9% of GDP in 2006. The trade deficit in 2005 was 9.3% of GDP. Figure 1 shows the balance of trade as % of exports and GDP and figure 2 shows the development of exports fob, imports fob and balance of trade fob.

Figure 1. Balance of trade fob-cif and fob-fob as % of exports and GDP 1997–2006




Figure 3. Exports and imports in % of GDP 1960-2006

Figure 3 shows exports and imports of goods in % of GDP over the last 46 years. According to this, the share of exports and imports has been around 25% of GDP with a slight decrease during the last few years. However, an exception to this is an increased share of imports in 2004–2006 as well as the share of exports which was down below 20% in 2005 but increased again in 2006. As the external trade share of GDP gets higher the more open the economy becomes. An external trade share of GDP around 25% for years, when looking at the external trade of goods only, does not indicate a more open economy. However the external trade of services has increased considerably during the last decades. For some years, fluctuations in the exchange rate can disturb such a comparison.

#### Changes in prices and volume 2005–2006

Exports and imports increased at constant exchange rates

The value of exports increased by 11.7% between 2005 and 2006 and the value of imports fob increased by 24.2% when account has been taken of a 11.8% increase in the average price of foreign exchange between the two years, as seen in table 3. The value of exported marine products increased by 1.0% at constant exchange

rates and the value of manufacturing products increased by 24.6%. There was a considerable increase in most items of the import, the largest increase was in the import of transport equipments (43.4%) and capital goods (28.4%).

Both export and import prices increased and terms of trade improved In Statistics Icelands's monthly publications on external trade, figures for the preceding year are converted to the average exchange rates for the current year in order to eliminate the effects of exchange rate changes on the nominal value. However, separating price and volume changes is only possible with the calculation of price indices. One way to calculate the price indices is to use unit values in each customs tariff number. Table 4 shows such indices. According to them export prices rose by 25.8% in terms of ISK from 2005 to 2006 and import prices rose by 17.8%. Hence, the terms of trade improved by 6.9% from 2005 to 2006.

Measured in ISK, the value of "general" exports was 22.6% higher in 2006 than the previous year, and export prices rose by 25.8%. In real terms, exports thus decreased by 2.5% from 2005 to 2006. The value of "general" imports fob increased by 29.8% in terms of ISK from 2005 and import prices rose by 17.8%, and thus imports increased by 10.2% in real terms.



### Exports and imports by main type of goods

Exports increased ...

Total exports in 2006, at current prices, increased by 48,400 million ISK or 24.9% as can be seen in table 5. Marine products made up 51.2% of all exports, or 124.400 million ISK, an increase of 14,200 million ISK or 12.9% from the year before. Figure 5 shows that during the last few years, the share of exported manufacturing products has been increasing, from 18.7% in 1994 to 38.3% in 2006, while the share of exported marine products has been decreasing, from 75.3% in 1994 to 51.2% in 2006. In 2006, the largest export category within marine products was that of demersal fish products, 33.7% of total exports, especially exports of cod which amounted to 47.900 million ISK or 19.7% of all exports. Next in line of exported marine products were exports of haddock, 13.4 million ISK, redfish, 10,000 million ISK, and herring with 9,800 million ISK export. The increase of exports of marine products was mainly due to increased exports of cod (5,900 million ISK). There was also an increase in the exports of herring (2,6 million ISK) and redfish (2,1 million ISK). On the other hand, there was a decrease in the exports of capelin (3,000 million ISK).

Manufacturing products accounted for 38.3% of total exports and the value of exported manufacturing products increased by 26,200 million ISK or 39.3% in 2006, the largest product being aluminium, 57,000 million ISK or 23.5% of total exports. Next in line were the exports of ferro-silicon, medicinal products, medical products and petroleum and petroleum products with export value of 5,700–5,900 million ISK. The largest increase within individual groups of manufactured products was in exports of aluminium, increase of 58.4% or 21,000 million ISK. In other products the exports of aircrafts had the largest share, accounted for 15,000 million ISK in 2006.

... and imports increased

Total imports in 2006 increased by 118,300 million ISK or 37.7%, at current prices (cf. table 6). The largest categories were industrial supplies with a share of 25.1% of total imports or 108,300 million ISK, capital goods with a share of 23.8% or 102.900 million ISK and transport equipments with a share of 22.4% or 96,900 million ISK. The largest increase in import values occurred in the import of transport equipments or 35,200 million ISK, of which the imports of aircrafts accounted for 30,600 million ISK. There was also an increase in the imports of capital goods (31,300 million ISK), industrial supplies (30,600 million ISK) and consumer goods, other than food and beverages (9,600 million ISK).




Figure 6. Imports by broad economic categories in 2006, in %

### External trade by market areas and countries

74,8% of exports went to the EEA and 64,7% of imports came from the EEA The European Economic Area¹ was the largest market area for Icelandic products in 2006. The share of exports to the EEA has decreased from 76.9% in 2002 to 74.8% in 2006 as can be seen in table 7. The share of the EEA countries in total imports has decreased from 66.0% in 2002 to 64.7% in 2006 as can be seen in table 8. In the same period, exports to the United States has remained the same but the imports from the United States has increased. Exports to Japan has decreased during the same period, but imports from Japan has increased.

The Netherlands was the largest trading partner buying Icelandic exports in 2006 while the largest share of imports to the country came from the United States. The exports to and imports from individual countries by commodities can be seen on Statistics Iceland's website, www.statice.is (External trade – Exports/Imports).






Figure 7. Exports by market areas 2001–2006

The Netherlands largest buyer of Icelandic goods

Five of the largest trading countries in 2006 bought 64% of total exports from Iceland, as compared with 62% in 2005 and 64% in 2004 (tables 7 and 9). The Netherlands was the biggest buyer of Icelandic goods in 2006, but in the third place the preceding years. The value of exports to the Netherlands amounted to 40,300 million ISK in 2006 or 16.6% of total exports, a increase of 65.9% from the year before at current prices. Marine products made up relatively small share of exports to the Netherlands, or 21.4% as industrial products, mainly aluminium, made up the largest share. The increase of export was mainly due to a increase in exports of aluminium but there was also an increase in the exports of cod.

In external trade the partner country is by classification the country of final destination of the export. If the final destination is not known the importing country is registered as such. Regarding the exports of aluminium to the Netherlands it is known that a large part of the export is redirected to other countries and therefore Netherland is the importing country but not the country of final destination. Figures for exports of aluminum to the Netherlands should be viewed with that in mind.

The United Kindom was the second largest buyer of Icelandic exports in 2006 but was the largest buyer the years before. Exports to the UK amounted to 37,900 million ISK, 15.6% of total exports. Exports to the UK increased by 9.6% from the year before at current prices. The main source of increase in the exports to the UK was due to increased exports marine products, mainly cod. The share of marine products of the total exports were 82.1%, mainly cod and haddock.

Germany was the third largest buyer of Icelandic exports in 2006 but was in the second place the two years before. Sales to Germany amounted to 36,300 million ISK or 15.0% of total exports, which was an increase of 18.0% from 2005 at current prices. The increase is mainly due to incresed exports of aluminium. Industrial products made up the largest share of exports to Germany, 80.4%.

The United States has the largest share of imports to Iceland Imports from the five leading importing countries amounted to 45% of the total imports in 2006 as compared with 46% in 2005 and 47% in 2004 (tables 8 and 10). In 2006 the United States was the country supplying the greatest share of imports to Iceland, rising from the second place the years before. Imports from the United States in 2006 amounted to 55,500 million ISK or 12.9% af total imports, an increase in value of 89.4% over 2005 at current prices. The major part of these imports consisted of machinery and transport equipments which were also the largest factor contributing to the increasing imports.

The second largest share of imports in 2006 came from Germany which was the largest supplier of goods to Iceland the last two years. Germany supplied goods worth 53,000 million ISK, 12.3% of total imports, increasing by 22.1% from 2005 at current prices. Machinery and transport equipments made up the greatest part of the imports and was also the main cause of the increasing imports.

Norway was in third place among importing countries in 2006, but was in the fifth place the year before. Imports from Norway in 2006 amounted to 30,400 million ISK, 7.0% of total imports, an increase in value of 38.8% from 2005 at current prices. About half of the imports were fuels and lubricants which was also the main reason for the increase in imports from Norway.





Figure 9. Exports and imports by main trading countries in 2006

Figures 9 and 10 show exports and imports by main trading countries in 2006 and the balance of trade vis-à-vis main trading countries in 2006. They show a

considerable surplus in the trade with the Netherlands whereas there was a deficit in the trade with Sweden and the United States.

As regards external trade by commodities and market areas (tables 11 and 12), the EEA countries had the largest share in Icelandic exports in 2006 or 74.8%. Marine products constituted 51.2% of the total exports, 78.4% of which were exported to EEA countries. The EEA bought 80.8% of Iceland's manufacturing exports. The largest category of imports was industrial supplies (25.1%) of which 68.1% came from the EEA. Appr. 96.8% of fuels and lubricants and about 70.8% of capital goods were imported from the EEA.

On Statistics Iceland's web site (www.statice.is), information is available on imports and exports by months, currencies, SITC classification, BEC classification, exports by commodities (SI classification) and by brances of processing as well as breakdown by countries, market areas and by countries and classification.
