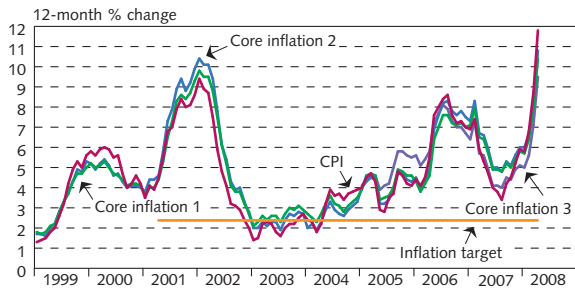

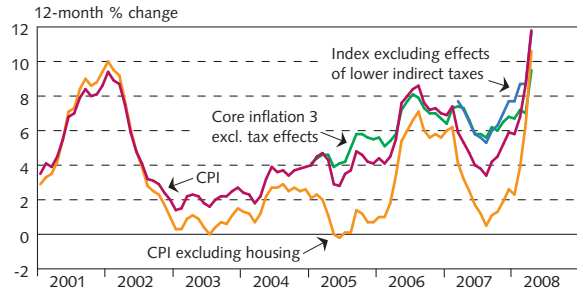

I-1 Consumer price inflation and core inflation¹

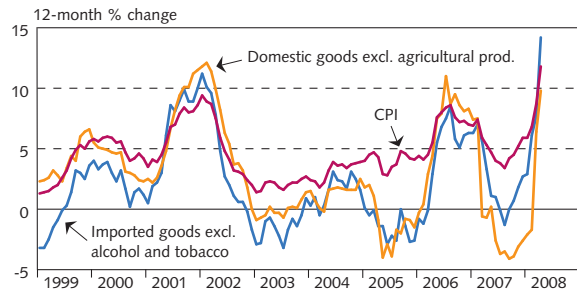

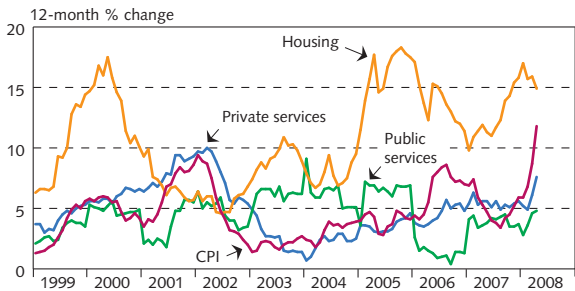
I-3 Components of CPI inflation
Contribution to inflation in past 12 months



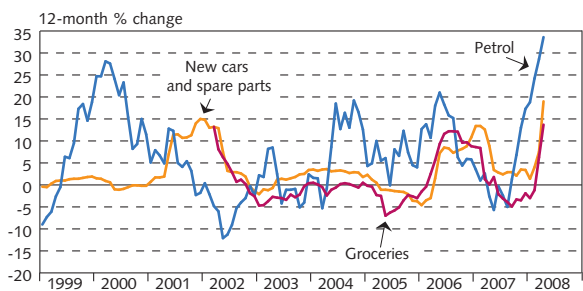

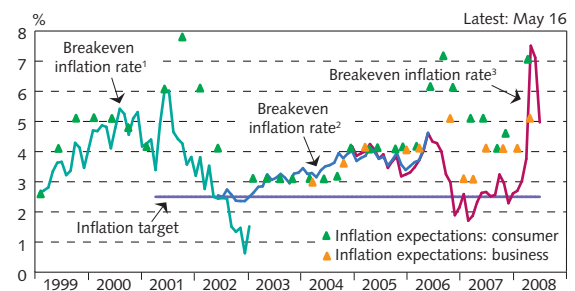

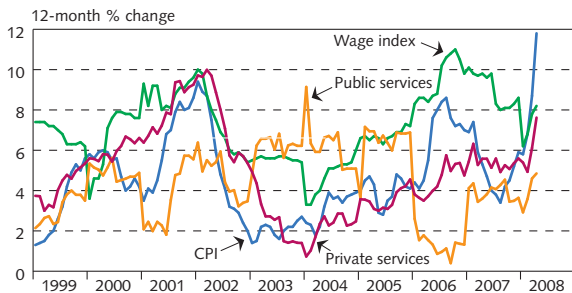

and inflation expectations according to surveys



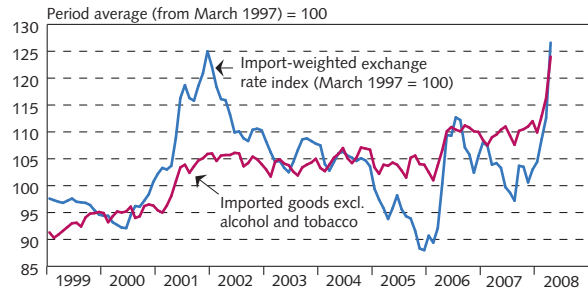

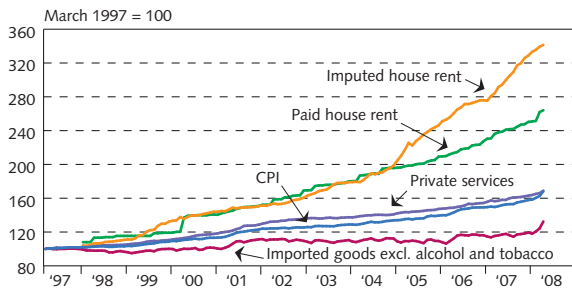

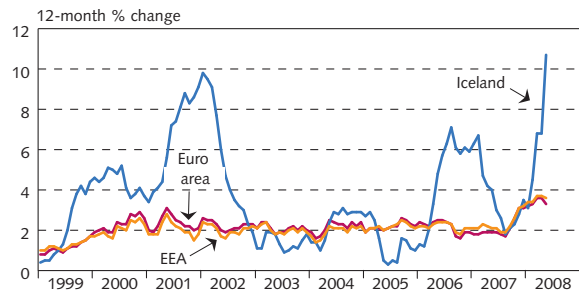
I-10 Prices of imported goods and exch. rate development

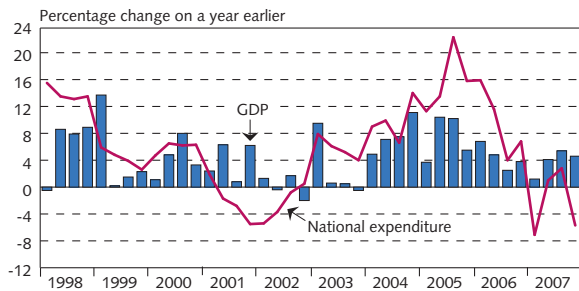


I-12 Inflation in Iceland and in Europe

January-December 2005 - 2007



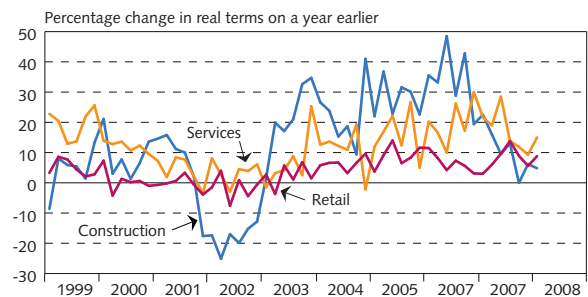

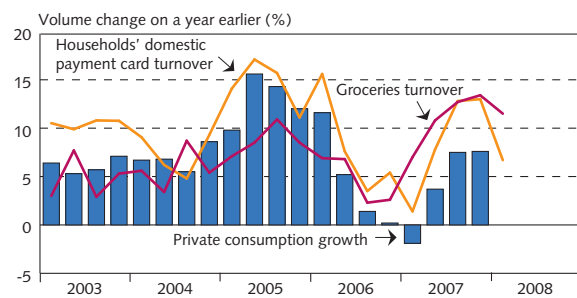
Groceries turnover

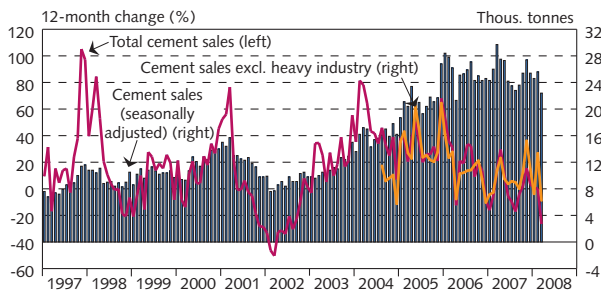

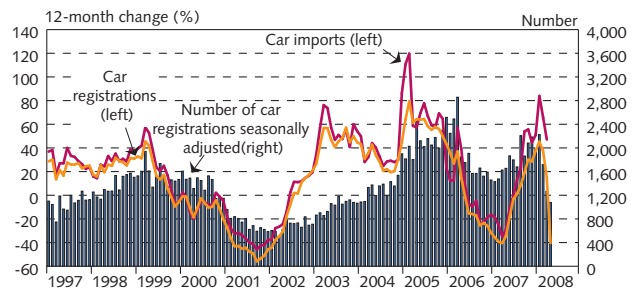

Monthly data, 3-month moving averages



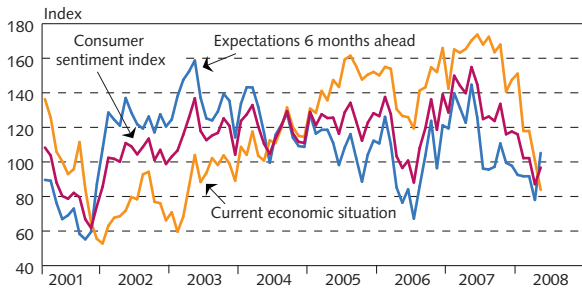

Net current transfer is included in factor income



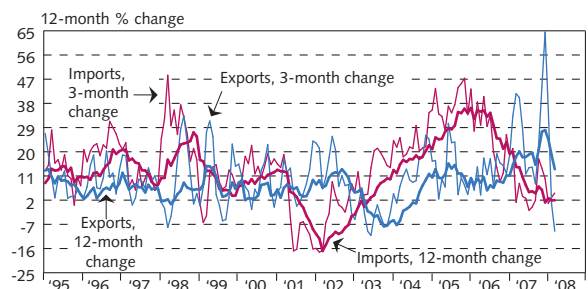

12-month moving averages



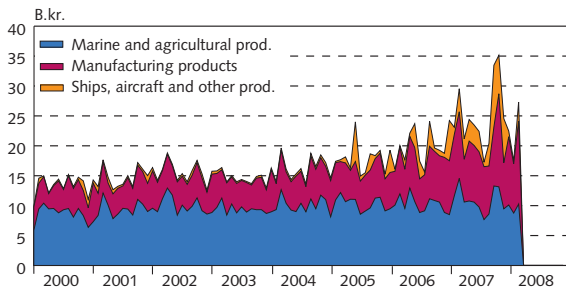

12- and 3-month moving averages, at fixed exchange rates

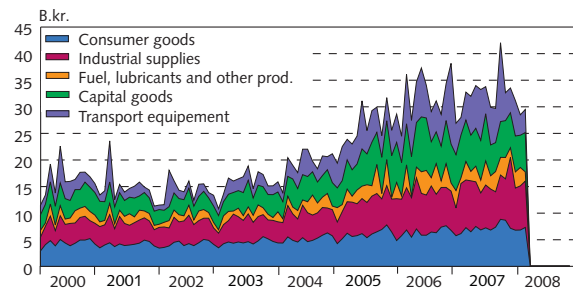

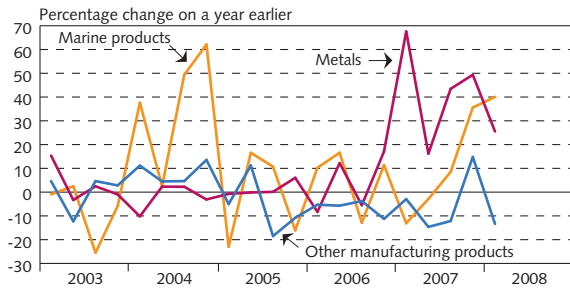

Export value at fixed prices



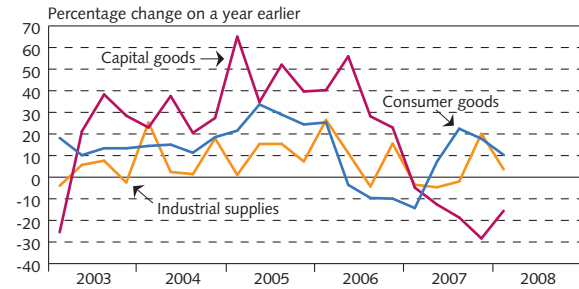

3-month moving averages, at fixed exchange rates



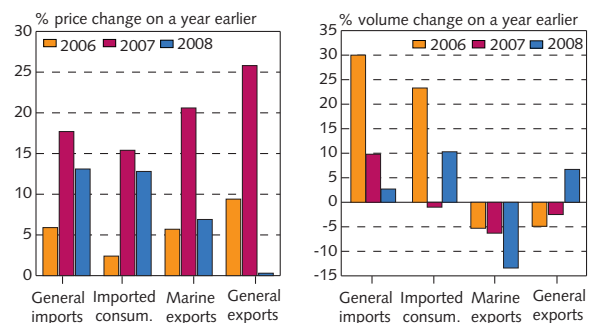

Currency-weighted for marine exports and in USD for aluminium



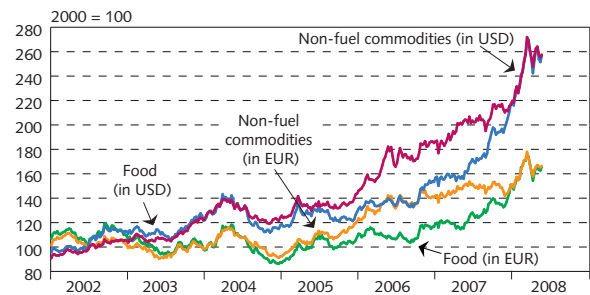

Forecast based on futures prices



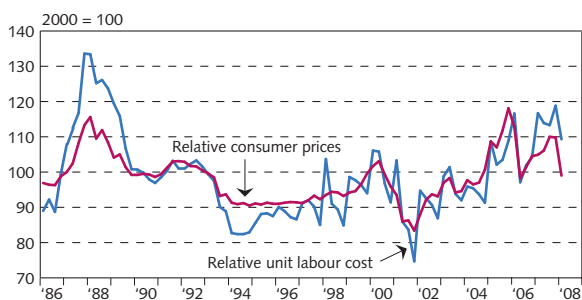

Statistics Iceland labour market survey



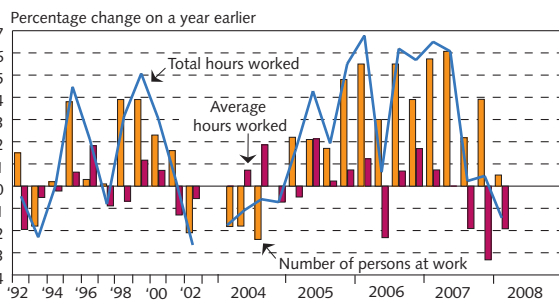

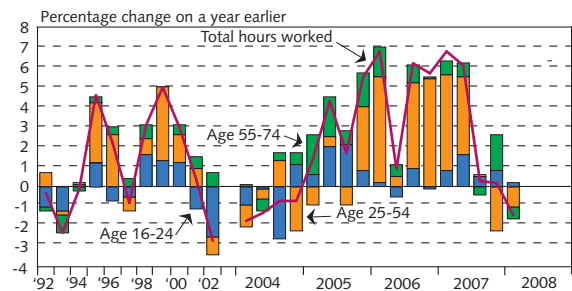

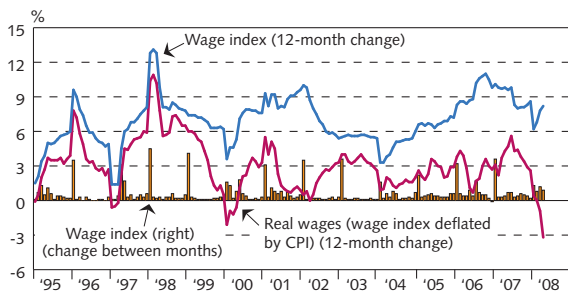

Contribution of age groups to total hours worked



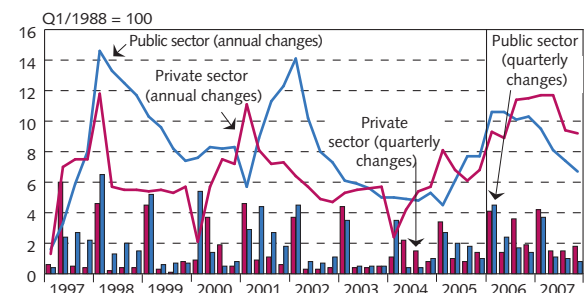

Statistics Iceland wage index



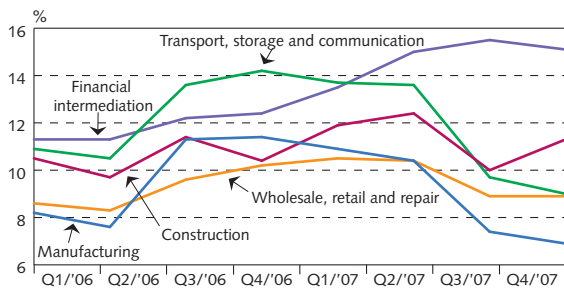

Statistics Iceland wage index

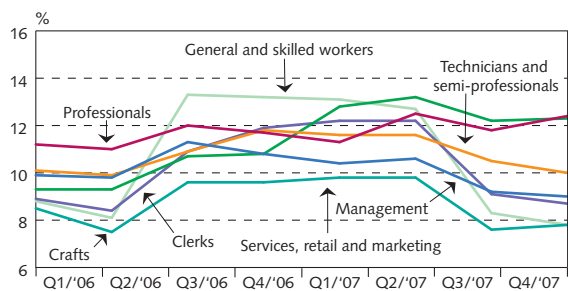

Percentage change on a year earlier

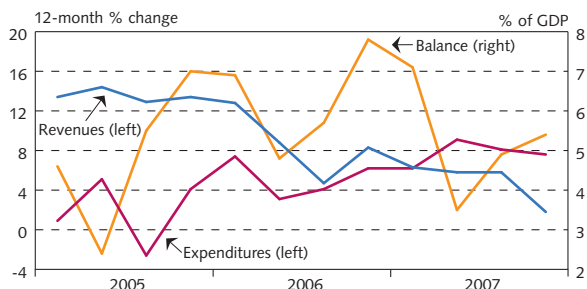

Percentage change on a year earlier

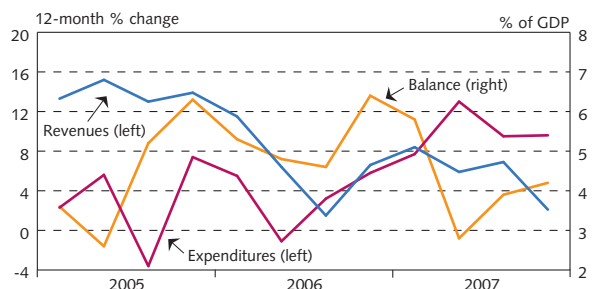

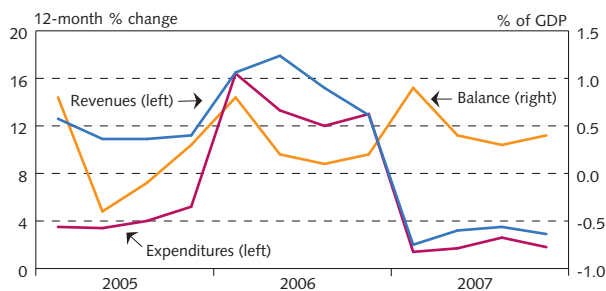

In real terms deflated by CPI



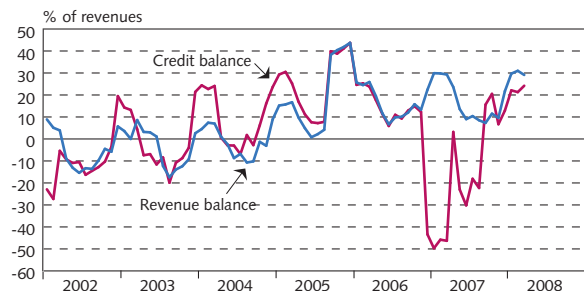

In real terms deflated by CPI



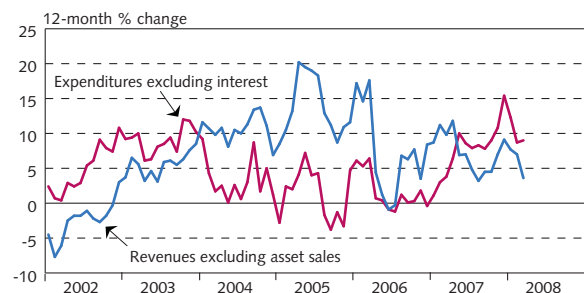

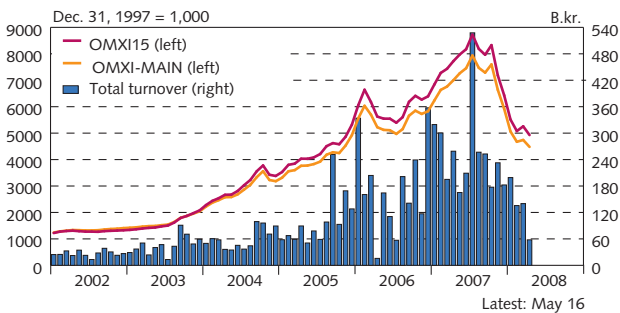
Treasury expenditures by function

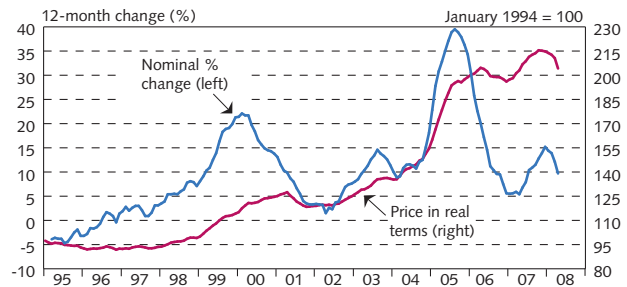

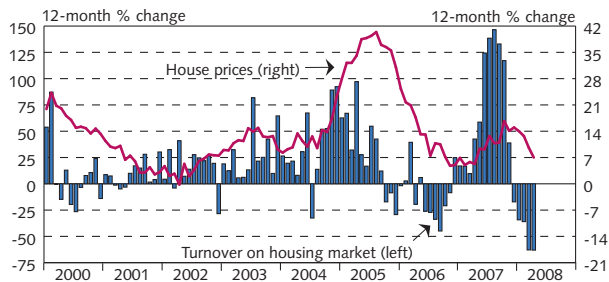

Price per m², 3-month moving averages



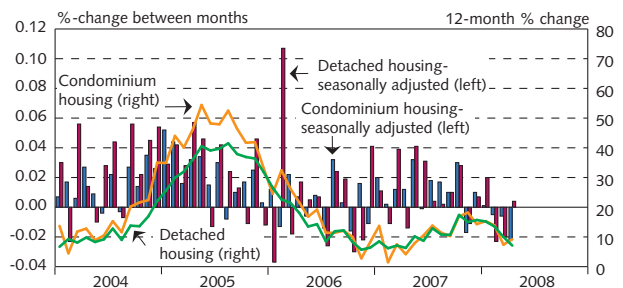

Monthly turnover and prices



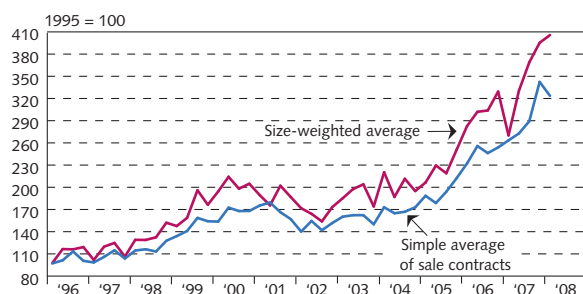

Condominiums and detached housing



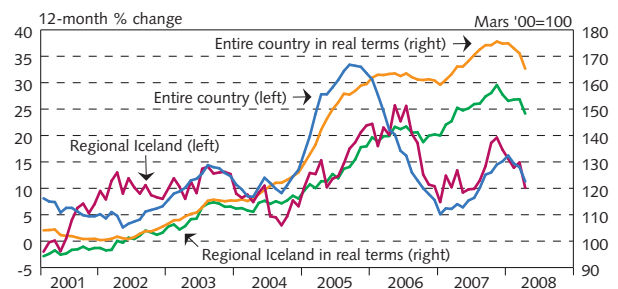

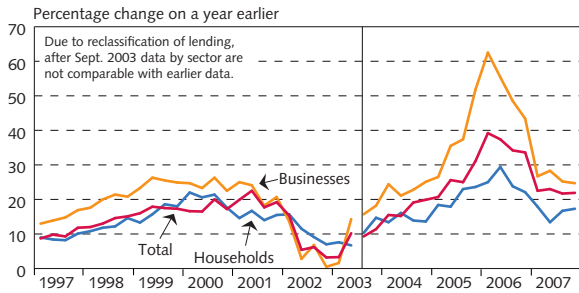
Market price of residential housing

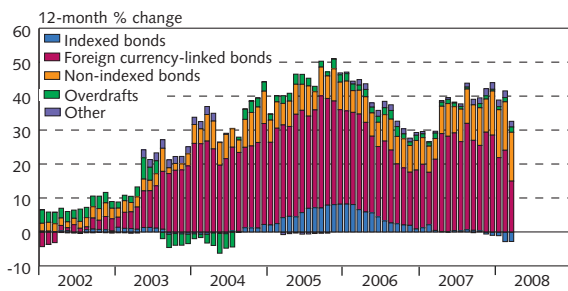

Contribution to credit growth



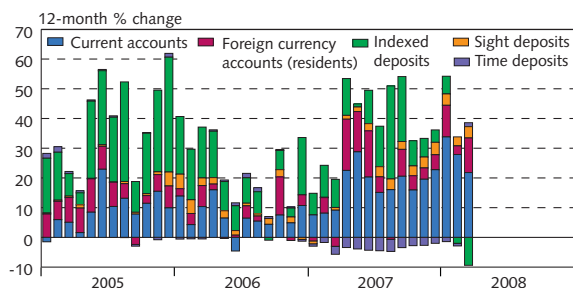

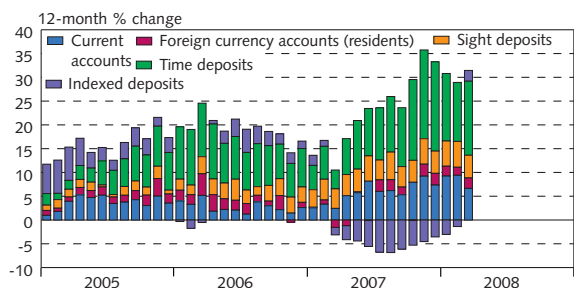

Contribution to deposit growth



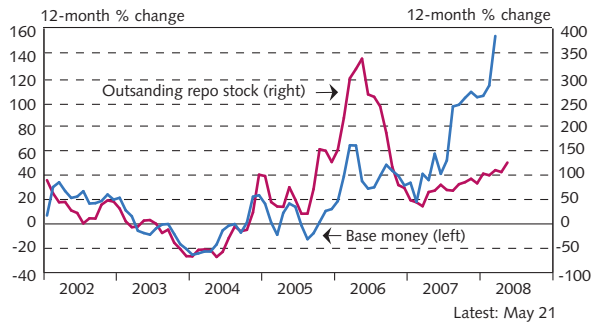

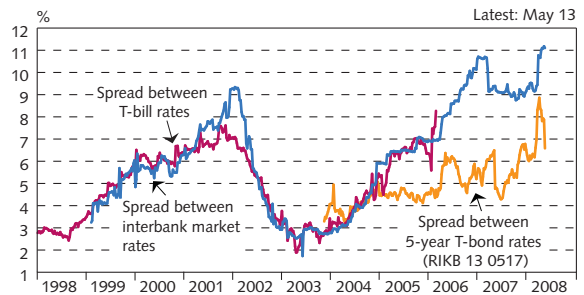

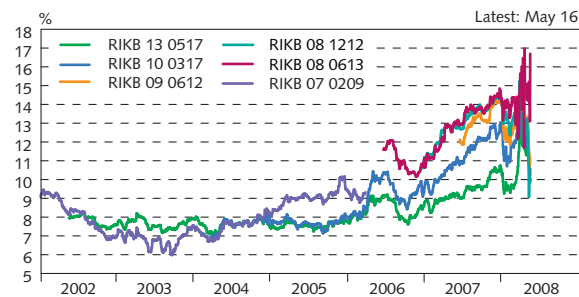

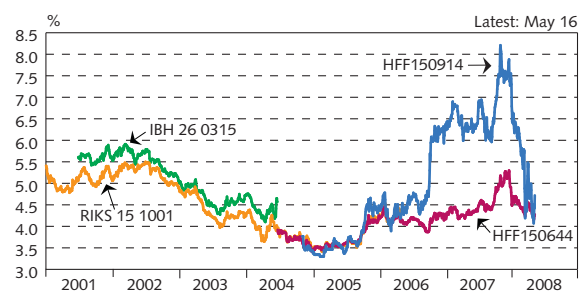

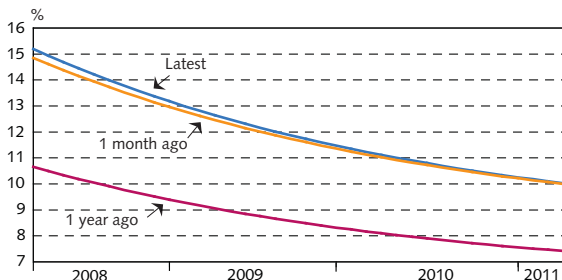

Bank lending rates, T-note yields and policy interest rate



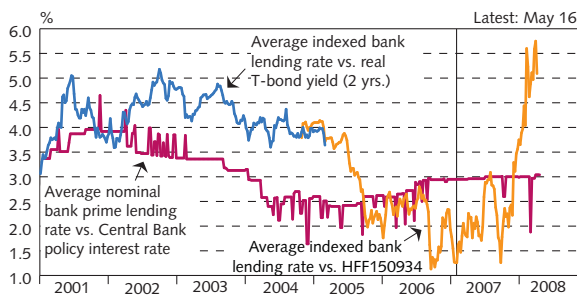

Bank lending rates and real yield on housing bonds and T-bonds



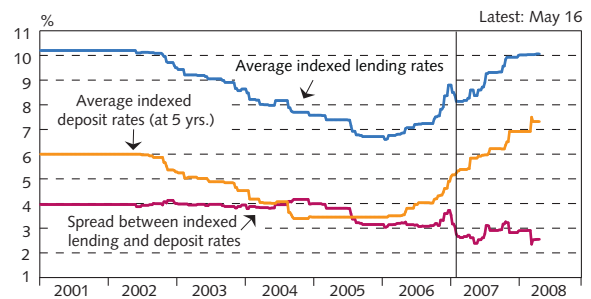

between indexed bank lending rates and T-bond yield



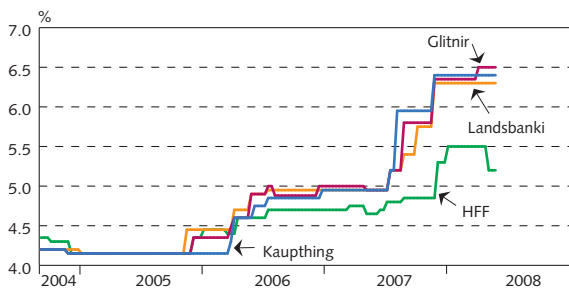

Indexed terms



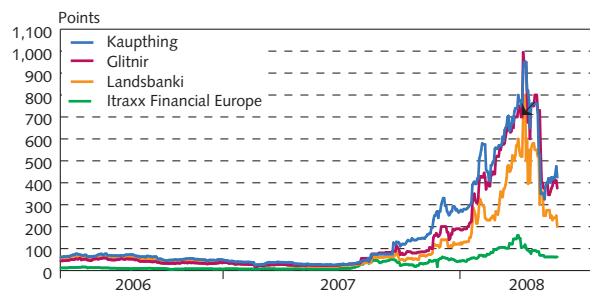

Housing loans' lowest interest rates



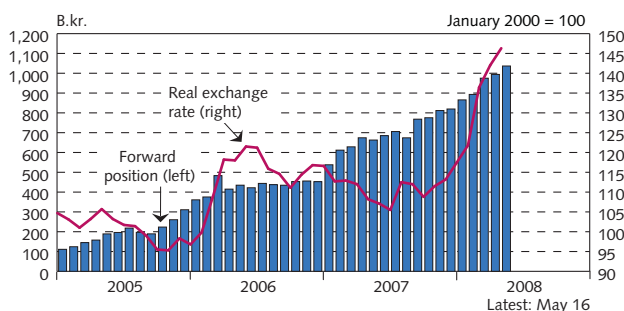

Daily data July 8, 2006 - May 16, 2008



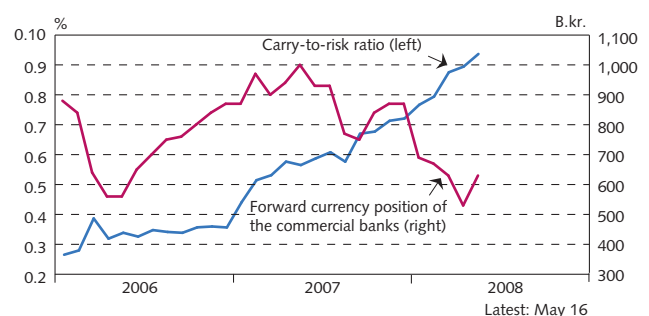

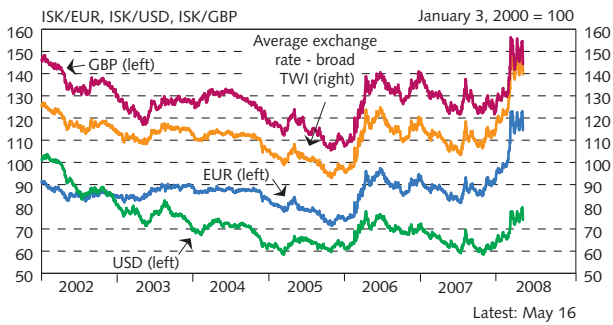
Carry-to-risk ratio and forward currency position of the commercial banks

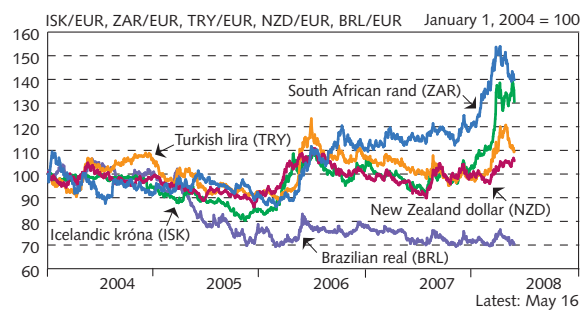

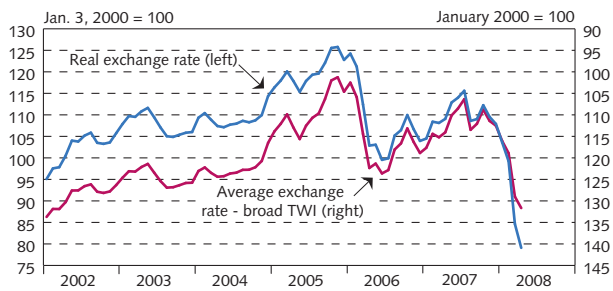
