Complaint	Cases opened on the basis of a complaint alleging that the EFTA States are not respecting their EEA obligations.
Conformity assessment	Cases opened to check whether national measures intended to implement EEA Acts conform to the content of the respective EEA Act.
Draft technical regulation (DTR)	Cases opened following notifications submitted by the EFTA States of Draft Technical Regulations (according to Directive 98/34/EC) for scrutiny by the Authority before they enter into force.
Incorrect implementation/application	Cases opened at the Authority's own initiative to examine whether a breach of EEA law has occurred or not.
Inspection	Cases opened in connection with on-the-spot inspections relating to food and feed safety, and aviation and maritime security.
Management task	Cases opened to perform various tasks arising from EEA law, e.g. to collect reports and information that the EFTA States are obliged to produce, examination of applications for derogations from the provision of an EEA Act, or publication obligations.
Notification	Cases opened when the EFTA States have not notified to the Authority the national measures intended to implement an EEA Act within the prescribed time-limits.
Reporting	Cases opened to produce reports where that is required of the Authority.
